



# St. Mary's School of Piscataway Tuition Rates 2025-2026

## Tuition

Pre-K	\$9,500 per year
Kindergarten – 8th Grade	\$8,750 per year

*The actual cost to educate a child at St. Mary's School of Piscataway is \$9,815.23 per student.*

† St. Mary's School of Piscataway provides additional tuition assistance for families with one or more enrolled children, based on calculated need.

## Minimum Age Requirement for the 2025-26 School Year

Pre-K3	Must be age 3 by September 1, 2025
Pre-K4	Must be age 4 by September 1, 2025
Kindergarten	Must be age 5 by September 1, 2025
Grade 1	Must be age 6 by September 1, 2025

## Fees for the 2025-26 School Year

Assessment & Testing Fee New Families	\$100 per student
Application Fee New Families	\$150 per student
Re-Enrollment (Returning Students)	\$200 per student
School Fees	\$575 per student
Home School Association	\$125 per family
Graduation (8th Grade Students Only)	\$150 per student

## Tuition Assistance

### Catholic Grant – \$1,500 Catholic Tuition Grant with Parish Verification

To be eligible for the \$1,500 Catholic Grant, students must be in grades Pre-K - 8, be active in a Catholic Parish, attend Mass weekly and participate in the life of the community of faith. In order to maintain the highest standards in our school and to keep our tuition affordable, each school family that is registered at St. Mary's Church of Piscataway is required to attend Mass and make use of the weekly contribution envelopes provided by the parish. In addition, the following criteria must be met.

- † Student has a Catholic baptismal certificate, and
- † Family is registered, contributing, and active in a Catholic parish in the Archdiocese of Washington, and
- † The Catholic Parish Verification Form has been submitted to the Admissions Director

### Military Family Award

- † Students of active duty military families receive \$800.00 off the base tuition rate.
- † Parent or legal guardian is **active** duty U.S. military.
- † A current, valid military ID must be provided to the registrar.

### Financial Need Awards

- † Current families, please apply on TADS by February 21, 2025.
- † Students in grades Pre-K through eighth grade may apply for financial aid.
- † Parents must submit a timely and complete TADS financial aid application in order to qualify for any tuition assistance
- † Archdiocese of Washington awards on average about 20% of the base tuition.

### BOOST Scholarship

- † Tuition assistance is available from the State of Maryland for private school students with significant financial need. The Broadening Options and Opportunities for Students Today (BOOST) Program provides scholarships for some students who are eligible for the free or reduced-price meals program to attend eligible nonpublic schools. Awards are granted based on household income, with the lowest income served first.

*The sum of all assistance, grants, and rewards may not equal more than 50% of the base tuition.*
